# **MINUTES**

Three members of the public were also present.

1. Apologies for absence

Apologies were received from Cllrs A. Hanks, J. Spicer (SCC), C Bull (WSDC) and from N. Spring (Clerk)

2. Members' declarations of interests and dispensations

None

3. Public participation session

The planning application for 47 dwellings in TheInetham Road was raised. Cllr Macklin reported that there was no decision yet, but that another ecological survey had been conducted.

A question was asked about the parking outside Market Weston Fen, and the large log that was in the turning space (field entrance) opposite. The log had been there for several years and was to stop unauthorized entry onto the field. It was not associated with Suffolk Wildlife Trust.

There were no reports provided and neither councillor was present.

Suffolk County Council have been informed about the poor state of the boardwalk between Fen Street and Greyhound Lane.

# 7. Reports from:

#### The Chair:

Thanks had been received and thank you cards produced by some of the children in the village on the receipt of their Jubilee commemorative mugs.

Hopton Bowls Club had put in an application to upgrade their licensing status and had reported that they had used 50% of the profits raised through the Jubilee events to purchase a large BBQ that will be used for future community events.

#### Councillors:

Cllr Hassan reported that ensuring that all children in the village had been given Jubilee mugs proved difficult with a number of home-schooled children.

Cllr Faiers had cleaned and repainted the village signpost by the shop, and had cleaned the old telephone box.

Cllr Delve had weeded Crooked Corner and watered a number of times as the plants establish.

Cllr Macklin suggested that a job description be produced for the village litter picker which could contain a few other small tasks. Cllr Faiers said that one had been produced in the past.

Burgess Homes had emailed and reported that the Council had asked for "calculations to satisfy the condition for surface water solution on the existing scheme." All of Burgess Home's existing calculations for the house types have been shelved and new calculations are being undertaken.

Burgess Homes still hopes that the building will start in late summer and have offered to come to a Parish Meeting later in the year.
